## **LOCATION**

GolfPlex is located in a very commercial location on the north west outskirts of Bracknell in Berkshire. The property benefits from an adjacent new residential development and has good visibility and road access.

GolfPlex draws from the continuing expansion of Bracknell. With the recent residential and commercial developments in the area together with future planned expansion, the business will continue to grow.

### **EXISITING FACILITIES**

#### **DRIVING RANGE**

State of the art 25-bay floodlit driving range fully automated with Toptracer Technology, Power Tees and robotic ball collection and grass cutting.

Food & drink hosted service to the 25 bays (includes 1 Party Bay).

Children can play the installed franchise interactive game, Angry Birds, which adds another dimension to their experience.

### CAFÉ/BAR

Attractive modern open plan café bar and check-in facility extending to 170 sq.m. and with seating capacity for up to 48 covers, with a further 48 covers on the range. The bar serves alcoholic as well as soft drinks. Pizzas and Paninis served in the café and driving range bays.

#### **SPORTS SIMULATOR**

A fully immersive and interactive facility with over 60 sports to choose from at over 3,000 sporting venues. This is popular and well used by children and adults.









#### **ADVENTURE GOLF**

The 22 hole Bear Mountain Adventure Golf comprises three themed courses namely, the 7 hole Polar Zone, the 8 hole Jungle Zone and the 7 hole Desert Zone. The three differing themes is unique and creates excellent repeat business.

#### **FOOTGOLF**

A 10 hole Footgolf course, with the option to rent further land to increase to the current 14 hole course, is a popular attraction for families and groups and increases the time spent at GolfPlex.

#### **PADEL**

There are currently three covered padel courts and one outdoor court. LED lighting throughout. WiFi, reception and viewing areas are also provided.







## **FUTURE DEVELOPMENT**

A planning application is being submitted to construct a further 4 Padel courts. The new courts will be operated by PadelStars on the same basis and on the same lease terms as the existing 4 courts. This will bring in substantial additional rental income and footfall to the business.

There is also an extant planning consent to extend the existing clubhouse footprint by a further 150 sq m.

All aspects of the business are run in house with the exception of the Padel facility which is on a lease to PadelStars.
