




#### **Basis of Disposal**

An Agreement for Lease followed by a new (minimum) 25 year FRI lease is available with annual rental offers invited.

The Lease will be contracted out of the Landlord & Tenant Act Security of Tenure Provisions.

## **Derby Golf Club**

Derby Golf Club (founded 1923) is a self-administered resident Club operating from Sinfin Golf Course with c. 380 members. The Club's principal aims are to encourage golf and to enable members to gain a handicap certificate / play in competitions. Club members pay either a full rack rate green fee or an annual subscription, and benefit from advance booking rights.

The Club currently enjoys a (terminable) Tenancy at Will over the clubhouse catering facilities and a short term agreement over those parts of the clubhouse used by the Club and its members.

Derby City Council expects the new Tenant to work closely with the Club in the joint aim of promoting golf for the enjoyment and benefit of all.

Sinfin Golf Course falls under the City of Derby Local Plan Review and forms part of the Sinfin / Sinfin Moor Green Wedge. Part of the site is within an Archaeological Alert Area and part is within a Flood Zone. There are also designated wildlife sites on or adjacent to the property.

Cotton Farmhouse and part of the greenkeeping building are locally listed as buildings of historical merit.

Derby City Council encourages proposals that seek to diversify the current golf facilities (as long as any such diversified uses are ancillary to golf).
